The Bowman class will take part in a novelty round in lieu of the Olympic Round.
(Wand Shoot)

Standings: Archers will compete in both the JOAD/FITA and Olympic Round (OR) or Novelty round. The JOAD Champion is based on final placement in JOAD/FITA Round. Olympic Round seeding is based on the JOAD/FITA Ranking Round. All ties will be broken via FITA rules. Junior USAT ranking points are based on current USA Archery rules.

Awards: Gold, Silver, and Bronze will be awarded to the JOAD Champion in Junior, Cadet, Cub, and Bowman divisions.
Gold, Silver, and Bronze will be awarded for the OR in Junior, Cadet, Cub divisions.
Special Awards for Bowman Wand Novelty round.

JOAD Championship and Olympic Round awards will be presented after the completion of each OR event on the field Sunday. Wand Novelty Round Awards will be presented after the completion on the field Sunday.

Eligibility

JOAD National Championship competitors must be a member of a JOAD Club **AND** be a USA Archery (NAA) member too. Please bring USA Archery membership card to present when checking in at tournament, or be prepared to purchase a USA Archery membership at check in time. NFAA membership is **not** applicable.

Dress Code

USA Archery Dress Code applies to Official practice & Competition days. Exception: International Teams may wear FITA code compliant uniforms. No Camouflage attire will be allowed at practice or tournament competition days. <http://usarchery.org/content/index/5093>

- Another day to experience competition shooting
- And being with your fellow archers

Historically, the “WAND SHOOT” was once a popular NAA novelty round, with its roots dating back to 19th century England. An archer would shoot at a pine wand 2 inches wide and 6 feet high at 100 yards for men and 60 yards for women. The contestants shot either 30 or 36 arrows.

In the standard Wand round 36 arrows are shot from 60 yards at a two inches by six feet piece of balsa wood or soft pine.

Modify for JOAD Nationals:

- When: Sunday morning, July 5th @ 10am.
- Target: You will be shooting at a five-inch by three feet strip of paper placed onto the target mat vertically to represent the wand.
- Distance: 30 meters
- Number of Arrows: 36 arrows~~ 12 ends of 3
- Scoring: Five points for each hit
- Practice: Will have 2 ends of practice. 6-arrow limit per end.
- Awards: Gold, Silver & Bronze for each class.
