Maximum of 3 events per player, 4th event at official discretion.
(Player's age must be under the age category as of Dec-31-2010).

Entry Deadline: Post marked by **July 15, 2010**. LATE ENTRIES WILL NOT BE ACCEPTED.
Players from foreign countries can register on-line at www.tournamentsoftware.com and pay at the tournament desk.

Entry Fees: \$50.00 per person for up to three events. Group discounts may be available.

Eligibility: The 2010 Li-Ning California International Junior Badminton Championships is open to all domestic and international badminton junior players. US players must have USAB membership, can be purchased at the tournament.

Awards: Medals or Trophies will be awarded to all winners, runner-ups, semi-finalists, and cons winners.

Conditions:

1. The tournament will be conducted in accordance with applicable BWF and USAB rules.
2. Events may be combined or played round robin format if not enough entries are received.
3. Consolation draws will be held for each applicable event.
4. Up to two Li-Ning feather shuttlecocks per match will be provided free of charge.
5. All matches will be played in the best 2 of 3 games using the BWF Rally Point Scoring System.
6. Officials could decide that consolation matches be one game only due to time constraints.
7. A player not ready to play five minutes after his/her match is called will be forfeit by default.
8. On court warm-ups is restricted to 3 minutes.
9. Each player in a doubles partnership must submit separate entry forms.
10. Entries will not be refunded if canceled after July 15, 2010.
11. The Tournament Director reserves the right to change any of the above conditions.
