Age requirement

The JWC competition is open for fencers with FIE license born 1992 or later
The Cadet competitions are open for fencers born 1995 or later.

Participating fencers need a FIE license for the 2011 – 2012 season.

Entry fee:

Junior World Cup: 15 EUR, paid at the moment of registration
Cadet competitions: 10 EUR, paid at the moment of registration

Competition formula:

The competition formula of the FIE Junior World Cup will be used, i.e., one round of pools, in which all fencers present take part, and an integral direct elimination of qualified fencers.

Equipment:

The fencers must have equipment in accordance with FIE's decisions (FIE blades, mask 1600N, fencing dress and plastron 800N). Fencers' equipment shall be controlled and approved by the equipment control before the start of the competition.

In the cadet competitions FIE blades are not required. The equipment will be checked by the referees on the pistes.

Doping control:

Only applicable for the JWC competition.

Quota of referees:

The Federations must bring referees at least in accordance with the FIE regulations:
1 - 4 fencers = 0 referee, 5 - 9 fencers = 1 referee, 10 fencers or more = 2 referees.
