Head Coach Level II & First Aid	\$35.00 an hour
Head Coach Level III & First Aid	\$45.00 an hour
Assistant Coach Level I & First Aid	\$21.00 an hour
Assistant Coach Level II & First Aid	\$25.00 an hour
Assistant Coach Level III & First Aid	\$35.00 an hour
Certified Trainer	\$20.00 an hour
Student Trainer	\$12.00 an hour
First Aid Provider	\$10.00 an hour

The independent contractor will be paid on the 15th of each month based on when the payment request is received from the Futures region. The independent contractor will declare, as the law requires, gross income and social security.

The independent contractor must arrive for each session one half hour prior to the scheduled start of the session. Departure time will be after all athletes have left the site and the equipment is collected.

The independent contractor agrees to have a Level I or higher coaching accreditation, current Basic Coach/Umpire membership (if a coach), and a current background check to participate as a staff member for the Futures Program.

The independent contractor agrees to follow the rules and regulations set forth by the Futures Program, to abide by the United States Olympic Committee's Coaching Code of Ethics, and to complete the duties assigned to him/her. You, as an independent contractor, have certain responsibilities to uphold. At the discretion of USA Field Hockey, you may be dismissed from your duties and position as a Futures Coach or Athletic Trainer. You will be paid for the sessions already completed.

If an airline ticket has been purchased for you to travel to a Futures Session, as an independent contractor, you agree to use the ticket on the scheduled date. If you break your contract for the date the airline ticket has been purchased, you are responsible to reimburse USA Field Hockey for the cost of the ticket. The airline ticket then becomes yours to use as the rules and regulations of the ticketing airline allows. If you drive to a Futures Session you will be reimbursed at \$.40 per mile for miles driven over 75 miles.

A principal purpose of this contract is to ensure that the independent contractor understands his/her obligations. If for any reason the independent contractor determines he/she cannot fulfill them, he/she will provide written notification to USA Field Hockey no later than one week before the scheduled Futures session.
